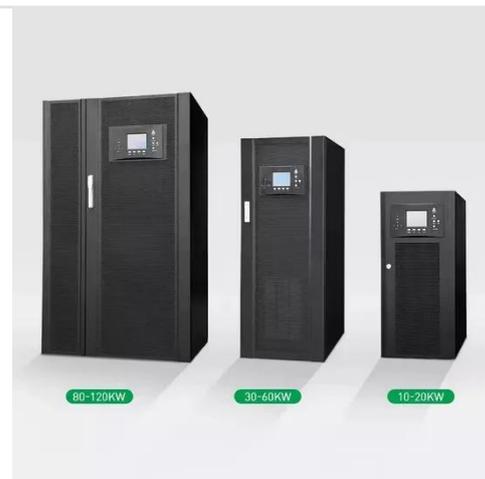
## Wireless Communication Facilities (WCFs) , City of San Diego ...

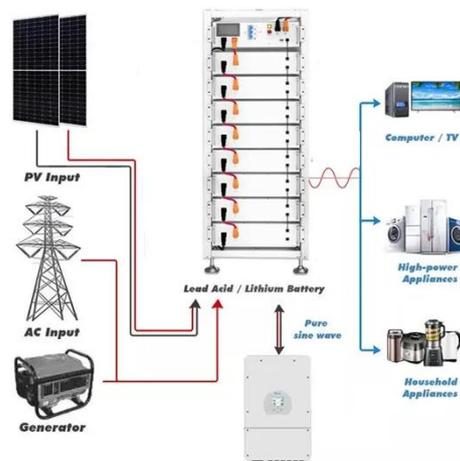
