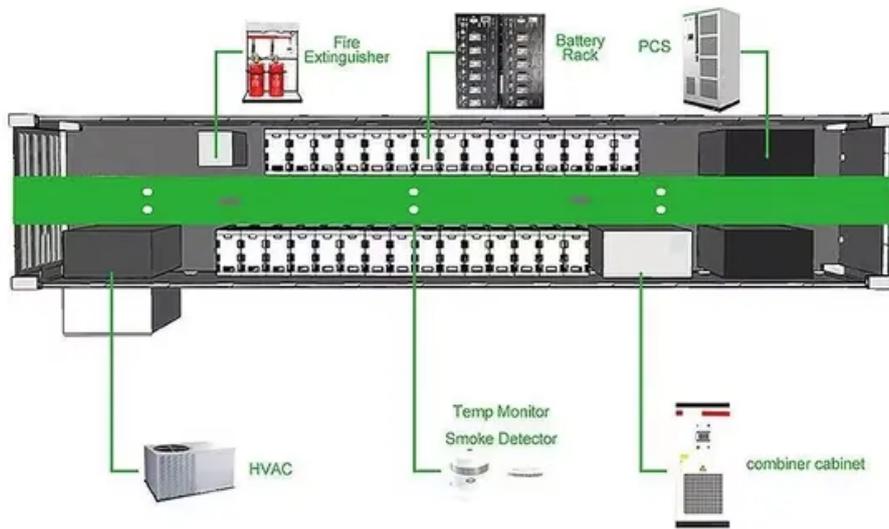


# Belgium load shifting




