

Fixed Investment in Microgrids



Overview

Microgrids can operate independently from the main grid, sustain essential services during outages, and help reduce strain on transmission and distribution infrastructure. Authorized by Section 40101(d) of the Bipartisan Infrastructure Law (BIL), the Grid Resilience State and Tribal Formula Grants program is designed to strengthen and modernize America's power grid against wildfires, extreme weather, and other natural disasters that are exacerbated by the climate. In fall 2019, the National Association of Regulatory Utility Commissioners (NARUC) and the National Association of State Energy Officials (NASEO) initiated a joint Microgrids State Working Group (MSWG), funded by the U. Department of Energy (DOE) Office of Electricity (OE). The MSWG aimed to bring. 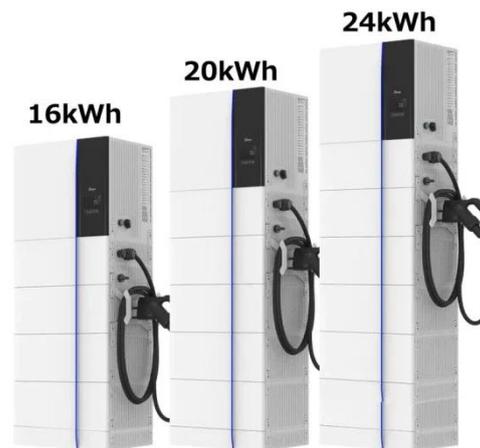
